## ADMINISTRATIVE REPORT – Executive Director & Administrative Services Manager

While we are having a busy season with aluminum, grain, salt and the breakwall project rocks we are also working diligently on our rail and port security projects. We have also submitted a Northern Border Regional Commission Grant. Our aluminum barge arrivals are on track, but some of our discharge turnaround times have not been what we have wanted them to be due to the conditions on the barges. We are working with the shippers to eliminate this problem in the future. With help from the company working on the breakwall we were able to fill a hole in the Westside Warf at a significant cost savings. The new floating gas dock has been installed. The dock was built in house at a great savings to the port. The port has purchased \$1,215,135.00 worth of equipment, from the Federal Surplus, for \$51,308.00. Some of the items we have purchase include trucks, top loaders and most recently two forklifts from Germany. Coming up in November is the annual HwyH20 Conference in Toronto, which we will be attending. This year we have become members of the American Association of Port Authorities (AAPA). The Army Corp. of Engineers break wall repair project is continuing on schedule and has been discussed in a number of news articles.
