ADMINISTRATIVE REPORT - Executive Director & Administrative Services Manager

There are currently three consecutive projects being worked on: the dock rail, the internal rail and the old Fitzgibbons site intermodal rail. There is also the port security grant being worked on which will also help to automate some of our processes. We procured a 2,500 ton crane for \$3,500 and two forklifts for use at our facility. Our aluminum operations have been going very well with increased efficiency. We have recently sponsored a couple of Syracuse Crunch Hockey Games and are starting to look at sponsorship requests that have been coming in for 2016. The port has been named one of the four pillars of CenterState. While the Executive Director has been spending quite a bit of time in Syracuse lately, Bill Scriber has been taking care of the daily operations at the port. We now have organic grains being stored here at the port, which require different equipment parameters at an additional cost. With harvest season in full swing, we are close to running out of storage space to store all the incoming grain. We trying to get more railcars in and ship in here to load out some of the grain as we expecting even more grain to come in.
